Sl. No.	The school is directed to ensure that :
1	The total number of section of the school shall be restricted to 33, of which not more than 1/3rd sections may be used for senior secondary classes. Any further increase will require prior permission of the board subject to compliance with the affiliation bye laws and availability of rooms of more than 500ft dimensions.
2	The page of trust deed where the name of trust reflected is missing. The school is required to upload all the pages of trust deed highlighting the name of trust and submit the same on SARAS portal within 3 months.
3	The fire safety certificate uploaded by the school is in vernacular language. The school is required to upload the notarized translated copy of valid fire safety certificate and submit the same on SARAS portal within 3 months.
4	The total land area mentioned in the OASIS 4138 sq mt with playground 5620 sq mt whereas as per land certificate it is 7942 sq mt, there is a variations in land area. The school is directed to apply for necessary correction on SARAS portal.
5	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws 2018.
